



# Satisfactory Academic Progress (SAP)


- Maintain a minimum grade point average (GPA) of 2.0
- Complete a minimum of 67% of cumulative credit hours attempted.
- Must complete program of study in a timeframe not to exceed 150% (1.5 times of expected completion) of the length of the program for full-time students.
