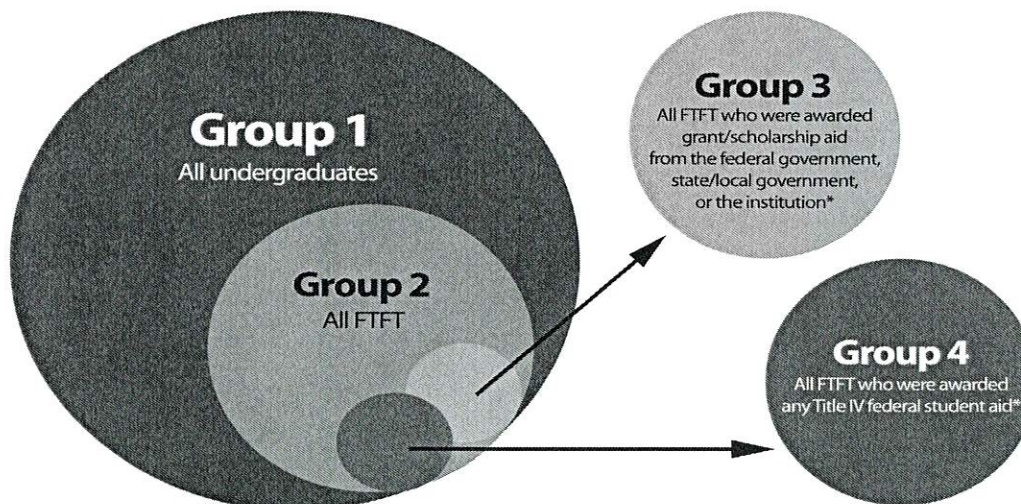

**COA Revisions**
