The Financial Aid Office at McDowell Technical Community College (MTCC) has determined that you are not meeting the satisfactory academic progress standards that are required for graduation at MTCC. Federal regulations require that institutions of higher education establish minimum standards of satisfactory academic progress including a minimum grade point average (GPA) and completion rate. At MTCC, students are required to maintain an overall GPA of 2.0 and completion rate of 67% in order to remain eligible for Federal and/or State Financial Aid. Students that fail to meet the minimum standards lose their eligibility for financial aid. Federal regulations allow Financial Aid Offices to extend eligibility to students not meeting minimum standards if the student provides proper documentation outlining any mitigating circumstances that have been experienced that might possibly have resulted in an unsatisfactory status. Examples of mitigating circumstances may include, but are not limited to: death of a relative, injury/ illness and/or hospitalization of the student or immediate family member, loss of home/ belongings/vehicle due to fire, accident or natural disaster, loss of employment/ income. Any circumstances cited in this appeal must have occurred in the semester with failing grades and/or withdrawn classes.

*Note:*

- *It is the student's responsibility to successfully complete all classes in which they are enrolled. Dropping, failing or withdrawing from a class is the student's decision and any classes within these categories will be considered in the calculation of satisfactory academic progress.*
- *Work will not be considered a hardship because the primary responsibility of financing an education remains with students and families. If eligible, students receive financial aid to supplement their educational expenses. These funds are not meant to cover the cost of all expenses if the student is not working.*
- *Childcare issues will not be considered a hardship as arrangements should have been made by the student prior to the beginning of classes.*
- *Any mitigating circumstances cited that relate to hospitalization/injury and/or illness should have accompanying documentation.*

**Incomplete appeals or those submitted without proper documentation will not be reviewed or considered.**

**Only one appeal per academic year will be considered.**
